SUPPLEMENTAL NOTICE OF CLASS ACTION SETTLEMENT

It appears from the records that you are a Member of the Class who is entitled to compensation from the Settlement of the above lawsuit. The information upon which the Settlement Administrator is relying, however, indicates that you leased your oil and gas interests to another entity or company after you signed an oil and gas lease naming Halcón as lessee in 2012. If you entered into a later oil and gas lease, you will receive a lower payment from the settlement than if you did not enter into a later lease.

(A) If you did not enter into a later oil and gas lease with another entity or company, you must sign under penalty of perjury and return the attached form to the Settlement Administrator so that you will be paid the proper amount.

(B) If you signed an oil and gas lease with another entity or company and your bonus amount was other than \$3,000 per acre, please insert the amount of your bonus payment (per acre), sign under penalty of perjury and return the attached form to the Settlement Administrator so that you will be paid the proper amount.
